Trey suggested that a member of this committee attend the species/Superintendent meeting at the fair to help reinforce these changes. Also that a member from this committee be present at the photo station to help track kids.

Samantha Ball presented some information regarding buying new livestock scales for the CCF, the fair was wondering if the Canyon County Market Livestock Committee would like to share in this cost of the scales. Every year we pay \$2000.00 to fix the scales and get them certified. Portable scales would be optimal for many reasons. We have the Opportunity to purchase new scales that are being used at the Denver Stock Shows in January 2023 and then sold at a Highly discounted price. Proposal was given to the COOP at the last meeting that we split this cost since we both use the scales. Purchase price would be \$10,000.00 from the Committee and \$10,000.00 from the Fair. The Scales come with a 5-year

warranty. The Seller said they have scales that they sold 30 years ago that are still in use. They will still need to be recertified each year.

Trey moved that the Canyon County Market Livestock Committee authorize purchase half the cost of two sets new livestock scales up to \$10,000.00. Second by: Malorie Turner

Janine Hodges amended the main motion to stating that the Canyon County Fair cover the cost of maintenance and certification in the future of these new scales. Second by Malorie Turner Motion Passed with Unanimous consent
