Latah County Family Horse Camp 2021

The Latah County Family Horse Camp will be held at the Pony Club grounds in Deary, ID. As a county we are providing this unique horse camp experience for local horse enthusiast. It is an opportunity for youth, leaders, parents, friends and family to share a great learning experience in a fun and safe environment. Different classes are offered each day, along with crafts, lectures and evening entertainment.

General Information

The horse camp is open to all area 4-H horse members, leaders, parents and local horse enthusiasts. The camp riding slots will be filled with preference given to Latah County 4-H horse members.

Each registered rider must bring a healthy horse that is in good physical shape and able to withstand four days of continual riding. No other horses are allowed on the grounds without approval of the camp planning committee. All horses must be current on vaccinations and should have proper hoof care before entering the camp, shoes are recommended.

Riders will be divided into groups according to skill level and they will keep these same groups throughout their camp experience. Classes will vary each day but may include up to five riding classes, a craft, a lecture and some free time.

Adult Riders and Non-riding Chaperones

Adults and family members are welcome to attend the 4-H horse camp as paid riders or paid non-riders/chaperones. This entitles them to activities and meals. Non-riders are welcome to watch and learn from all riding classes.



Chaperones

Chaperones are required for all youth under the age of 18. It will be the chaperone's duty to assist youth with their horses, getting ready for classes, following safety rules and supervising them until lights out is called at night. All youth must have a chaperone and no chaperone will be responsible for more than four youth.

Chaperones are welcome to split the chaperone duty. The horse camp committee MUST be notified before the camp begins if a youth will have different chaperones throughout camp. All chaperones must register and be approved by the youth's parent(s) and the horse camp committee.

Registration

ALL participants attending the Latah County Family Horse Camp MUST submit the following:



- 1. University of Idaho 4-H Horse Program Registration / Permission / Waiver
- 2. The appropriate fees
- 3. Rider Application, signed rules and protocol pages
- 4. Chaperone's Application must be submitted with the rider's application if the rider is under 18.
- 5. Camper or Tent Registration and Fee

Completed applications are due by July 01, 2021

Registrations received after the deadline will be set aside and considered only if vacancies exist. If applications exceed the limited number of riding slots, clubs within Latah County will be allotted spots based on the number of 4-H members enrolled in that club. After a club has filled their allotted spaces, excess registrations from that club will be placed on a waiting list. Vacant slots will be filled from the list based on the date the application was received. If vacant slots still exist, they will be filled by 4-H horse members applying from outside Latah County on a lottery basis. Any remaining slots will be open to area horse enthusiasts.

Registration forms will only be accepted when all required information and signatures are in place and all camp fees are submitted. **This will be strictly enforced**.

A chaperone's name MUST be on a member's registration form as well as that chaperones completed registration and fees turned in.

If a youth CANNOT find a chaperone, please call one of the camp committee leaders and we will assist you if at all possible. It is our goal to have parents involved with their children at the camp, and we strongly encourage parents to chaperone their own children.

If a registration form is found to be incomplete, it will not be considered as submitted and that person will be notified so that they may complete the form and re-apply.

Fees

Youth Riding Registration \$100.00 per youth rider (18 and under)

* This includes all meals, all riding classes, lectures, crafts, trail rides and evening activities.

Adult Riding Registration \$160.00 per adult rider (19 and older)

* This includes all meals, all riding classes, lectures, crafts, trail rides and evening activities.

Non-Riding Registration \$120 per person (all parents, leaders, sibling, 4-H youth not wanting to ride, there is no fee for siblings 5 and under)

- * This would include parents and siblings that stay overnight for the entire camp. (Parents or siblings that just want to come for the day are mentioned below.)
- *This includes all meals, lectures, viewing of all riding classes, and evening activities.

Extra Meals, Day Fees Are available for parents or sibling who decide to come watch for a day. We reserve the right to limit any and all last minute extra meal sign ups, depending on food supply and preparation. The fee for extra meals will be \$10.00 per meal. If you know that you will have guests for a particular day please let the planning committee know when you register.

Release Forms

Each participant (rider, leader, parent, sibling, instructor, helper, etc.) attending the Latah County Family Horse Camp MUST sign the Acknowledgement of Risk and Waiver of Liability form. Any medical expenses incurred are the responsibility of the individual or family.

All signed forms are kept confidential and will be used only in the case of an emergency.

Included in this camp packet is a list of horse camp rules and protocols that must be signed before your registration will be counted as complete. We ask that all participants in the horse camp follow these rules and protocols to make this the best possible learning experience for everyone involved.

Food

Eleven meals are provided for all paid camp participants.

That will include the following:

- *breakfast for four days Thursday, Friday, Saturday, and Sunday
- *lunch for four days Thursday, Friday, Saturday, and Sunday
- *dinner for three days Thursday, Friday and Saturday

Hot and cold beverages will be available at all times (not pop).

Camp participants need to bring their own snacks for between meals, if needed. Silverware, cups and plates will be provided for all meals. Everyone is encouraged to bring a personalized water bottle to minimize the use of disposable cups and to keep water handy for each youth that is riding.

Meal Preparation and Serving

All riders in the camp are **REQUIRED** to show up for all meals. Announcements will be made at these meals and it is important for all to be present. All riders will take turns helping in the cook shack where they will be responsible for setting up for meals and cleaning up afterwards. This schedule will be posted along with the camp rules outside the cook shack. Chaperones are responsible for getting all youth in their care to their respective duties on time.

Camp Operations

The camp facilities offer a wonderful eating and craft area, great individual pens for the horses, miles of trail riding, and multiple arenas for our use. They do not, however, offer individual stalls for the people. Therefore, it is suggested that you bring your own tent, camper, horse trailer, or whatever you wish to sleep in. There are no electrical or water hookups. However, shower facilities are available on the grounds. Water for the horses and people will be provided.

Everyone should try to leave as minimal an impact on their camping site as possible. Multiple trash cans are provided, and chaperones need to help their youth keep areas clean. Pens for the horses will need to be cleaned and checked before any rider leaves the camp on Sunday.

Horses are to be put into stalls when not being ridden. No horses are to be around the cooking area, craft area, or camping areas.

Dogs will be allowed on the grounds during horse camp, with <u>PRIOR</u> written approval from the camp committee. Dogs must be on a leash at all times. Bicycles, strollers, etc. are not encouraged, as they do not mix well with horses.

In the Event of an Emergency

Latah County 4-H Horse Camp Committee members will post in a designated location the phone numbers for local Emergency Medical Service (EMS), police, fire department and veterinarian, the name and phone number of the nearest hospital with directions to that facility, directions to the location of the event for EMS.

Each member of the horse camp committee should be aware of the location of emergency personnel on the grounds, emergency phone numbers, and the location of local emergency medical facilities.

Class Schedule and Safety Check

The class schedule, along with the group to which each rider is assigned, will be handed out Thursday in your camp packet. This information will also be posted at the cook shack, along with specific meal work assignments. There will be a mandatory safety check of your tack. Please come prepared - oil your leather, make sure your headstall is in good repair, make sure your latigo and off billet are not threadbare and worn through, etc. Make sure your saddle fits your horse and is not rubbing on their withers, check your horses' feet and have a qualified farrier trim or shoe them within 6 weeks of camp. If you have any questions have your 4-H leader or adult go over your tack with you before coming to horse camp!!

Time Schedule

All attendees MUST arrive at camp on Wednesday, July 14th.

Arrival time is 4:00 pm to 7:30 pm on Wednesday

Horse camp starts Thursday, July 15th with breakfast at 8:00am.

Classes may include Western, English, ground work, roping, drill team, sidesaddle, bareback, obstacles, and much more. Classes are subject to change.

Vaccinations

All horses are <u>required</u> to have a current 5 way vaccination. A 5 way booster is highly recommended within 1 month of camp. The Strangles vaccination is also recommended. When you have any number of horses coming together like this it is easy to transmit contagious disease from one horse to another. While a Coggins test is suggested, it is not required unless the horse is from out-of-state.

What to Bring to Camp

- ☐ Feed for 5 days for your horse (hay, grain, salt) Weed Free hay is recommended.
- □ Water bucket(s)
- ☐ Clean tack—saddle, bridle, extra tack, saddle blanket, grooming supplies, hoof pick, extra bridle, snaffle bit if available, etc
- □ English tack if you have it
- ☐ First aid supplies for you and your horse
- □ Pitchfork, shovel, rake, wheel barrow
- Shavings for stall bedding, Straw is NOT ALLOWED
- ☐ Insect repellent for both you and your horse
- ☐ Rain gear (for you and your saddle)
- **RIDING HELMET** required if rider is under 18 or you DO NOT ride.
- □ Sleeping bag, pillow, extra blankets, tent, lawn chairs, etc.
- □ Towels, washcloths, personal toiletries
- □ Long pants and boots are required while riding.
- □ Sunscreen only shirts with shoulders must be worn to prevent sun burns (no tank tops)
- ☐ Lariat if you own one we may have a roping session with ropes available but you are free to use your own if you have it.
- ☐ Flashlight, Reusable Water Bottle
- □ Camera (optional)

Anything you think you will need to make you and your horse comfortable while at horse camp.

DO NOT BRING VALUABLES OR MONEY



Rules

Care for your horse first! Horses should be fed and watered by 6:30 am, provided a light snack at noon, and fed and watered in the evening.

Participants are expected to take care of their own horses.

Use the water provided for horses.

Horses must be recently shod or trimmed.

Keep camp clean at all times. Clean out your horses' stall each day. Before you leave on Sunday, your pen and camping area must pass a cleanliness inspection.

Campfires and fireworks are not permitted, without camp Director authorization.

Trees, shrubs, flowers are not to be cut or carved under any circumstances.

Do not tie horses to trees.

Participants are expected to be on time for and attend all classes as assigned.

Helmets and proper attire (boots with a heel, long pants) are required whenever riding.

Horses must be bridled when ridden. Between classes, horses will only be ridden at a walk.

No riding double.

All riding, including evening pleasure rides, shall be under adult supervision.

Only riding participants are allowed to bring horses and ride.

Dogs allowed with <u>PRIOR</u> written approval, from the camp committee, dogs <u>MUST</u> be on a leash at all times

No bicycles, ATV's, or motorbikes are allowed

Participants must stay within the fenced camp area at all times.

Those under 18 years of age must be responsible to an adult attending camp. One adult chaperone will not be responsible for more than 4 minors.

In accordance with state 4-H policies, possession or consumption of alcoholic beverages is strictly forbidden.


* The Horse Camp Committee reserves the right to immediately expel anyone from the camp and grounds should any of these rules be broken, or the horse or rider are deemed unsafe.



Directions to Horse Camp

The Latah County 4-H horse camp will be held at the Pony Club grounds located just east of Deary, Idaho. The address is 5420 Highway 8 Deary, Idaho. Follow Highway 8 from Moscow through Troy and Deary. The Pony Club Grounds are on your left approximately two miles past Deary. About 500 feet before the entrance to the grounds, there is a small white sign along side the road that says "Pony Club Grounds 500 feet." The grounds are easily seen from the highway if you should happen to miss the entrance. Just turn around and come on back!

All camp participants must stop at the covered shelter, will be issued a camp packet, horses will be checked in, and a volunteer will guide you from there.

Registration Guidelines

Latah County 4-H Horse Camp July 14-18, 2021

Completed Registrations- Must be received by July 01, 2021

Registration forms will only be accepted when all required information and signatures are in place and the fee (\$100.00 for youth riders, \$160.00 for adult riders, \$120 for non-riders/chaperone's) is submitted.

A chaperone's name must be on each member's registration form, and that chaperones completed registration and fees must accompany the member's application before the member's registration will be considered complete.

For a completed registration, make sure you have the following forms filled out:

- 1. Rider Application form (one per rider) and signed rules and protocol pages
- 2. Chaperone/Guest Application form (one per person attending)
- 3. University of Idaho 4-H Horse Program Registration / Permission / Waiver (one per person attending with parent/guardian signature)
- 4. Camper or Tent Registration and Fee

If a registration form is found to be incomplete, it will not be considered as submitted and that person will be notified so they might complete the form and reapply. Registration positions will not be held for incomplete registration forms.

Fees

The registration fee covers all classes, meals, crafts, lecture materials (if any), safety materials, and rental of an English saddle.

The entire registration fee is due with this registration form. It will be held until you have been accepted to camp shortly after the July 01st application deadline. Once you are accepted the registration fee becomes NON-REFUNDABLE unless you are unable to attend horse camp for medical reasons. A doctor's signature may be required to receive a refund.

The total cost of horse camp is \$100 youth rider, \$160 adult rider, \$120 chaperone/non-rider.

- 1) Care for your horse first! Horses should be fed and watered by 6:30am, provided a light snack at noon, and fed and watered in the evening.
- 2) Participants are expected to take care of their own horses.
- 3) Use the water provided for horses.
- 4) Do not leave horses tied to trailers unattended.
- 5) Horses must be recently shod or trimmed.
- 6) Keep camp clean at all times. Clean out horse pens each day. <u>Before you leave</u> on Sunday, your pen and camping area must pass a cleanliness inspection.
- 7) Campfires and fireworks are not permitted.
- 8) Trees, shrubs, flowers are not to be cut or carved under any circumstances.
- 9) Do not tie horses to trees.
- 10) Participants are expected to be on time for and attend all classes as assigned.
- 11) Helmets and proper attire (boots, long pants, no tank-tops) are required whenever riding. No flip flops at any time! Closed toed shoes must be worn at all times.
- 12) Horses must be bridled when ridden. Between classes, horses will only be ridden at a walk. No riding double.
- 13) All riding, including evening pleasure rides, shall be under 4-H leader supervision and completed by 8pm.
- 14) Only riders are allowed to bring horses and ride. Other horses will be allowed only if they are necessary for a class.
- 15) All participants <u>MUST</u> remain on the grounds at all times, unless approval is given from the Camp Director.
- 16) Dogs allowed with <u>PRIOR</u> written approval, from the camp committee, dogs <u>MUST</u> be on a leash at all times.
- 17) No bicycles, ATV's, or motorbikes are allowed.
- 18) Participants must stay within the fenced camp area at all times.
- 19) Those under 18 years of age must be responsible to an adult attending camp. One adult chaperone will not be responsible for more than 4 minors.
- 20) In accordance with state 4-H policies, possession or consumption of alcoholic beverages is strictly forbidden.

Safety Protocol Latah County 4-H Horse Camp July 14-18, 2021

Prior to the first ride, a tack inspection will be conducted for safety. All horses and tack are subject to the safety check, and everyone must participate. To prepare for this check, examine your tack to ensure that it is not dangerously worn and properly adjusted for you and your horse. Also, check your stirrup length.

During the safety check the rider must be able to demonstrate the ability to:

- Groom their horse with little or no assistance
- ❖ Tack their horse with little or no assistance
- Mount their horse with little or no assistance
- Ride their horse with no assistance

Discipline Protocol

Discipline Protocol-

Adult Volunteers: Any adult can address small issues. i.e. throwing rocks, unsafe practices around or while riding your horse, etc.

Major Offenses: The Camp Director, Camp Committee, and an Adult Instructor will address the problem for major offenses. i.e. abuse of animals, bullying of others, etc

Automatic Dismissal: Adults and Campers will be automatically dismissed if any of following should happen: fireworks, smoking, drugs, alcohol, or if someone is put in imminent danger.

These rules are primarily for your safety and the safety of others.

I, the undersigned participant or parent/guardian, am aware that participation in the Latah County Family Horse Camp ("Activity") may include activities that are risky and dangerous. Both participant and his/her parent(s) / guardian(s) ("I") acknowledge and accept the risks and give permission for my participation in the Activity. I acknowledge that participation in this Activity has the following non-exhaustive list of particular activities that bear risk and danger and from which bodily injury to myself, or my child, up to and including death, may occur: physical activities related to camping, backpacking, hiking, or outdoor survival including, but not limited to bending, carrying heavy objects, cooking, falling, hiking, jumping, lifting, pulling, stretching, tripping, twisting, wading, and walking that involve strenuous exertion that could place stress on cardiovascular and/or musculo-skeletal systems and result in cuts, burns, puncture wounds, broken bones, strain, sprains, joint injuries, heart malfunctions, eye injuries, concussions, and head injuries; risks include, but are not limited to, those arising from control and performance of horses that, with or without warning or any apparent cause and regardless of previous training and past performance, could make unpredictable movements, including but not limited to, bucking, kicking, rearing, running, jumping obstacles, stumbling, rolling, falling, biting, pawing, stepping on or moving people or things; physical activities that may involve strenuous exertion that could place stress on cardiovascular and/or musculo-skeletal systems including but not limited controlling a horse while on the ground or riding, lifting, pulling, stretching, or jumping that could result in cuts, punctures, bone fractures, muscle strains and sprains, concussions, head injuries, eye injuries, and heart malfunctions; activities supplemental to the Activity, such as loading and unloading animals from horse trailers, controlling animals while in unfamiliar area and around other animals; use or operation, by me or others with varying skill levels, of animals, and tack, in the condition in which they are found; and risks arising from control, performance or being in the presence of livestock that with or without warning or any apparent cause and regardless of previous training and past performance, could make unpredictable movements; physical activities related to touring livestock facilities including, but not limited to falling, lifting, bending, jumping, pulling, tripping, and twisting that involve strenuous exertion that could place stress on cardiovascular and/or musculo-skeletal systems and result in cuts, punctures, broken bones, strain, sprains, joint injuries, eye injuries, heart malfunctions, concussions, and head injuries; risks related to transit to or from the Activity locations including, but not limited to,

travel by private auto, including travel in unpredictable or extreme weather conditions that affect the method of travel safety; use or operation, by me or others of equipment in the condition in which they are found; exposure to inclement weather including, but not limited to rain, sun, wind, snow, ice, fog, and extremes of heat or cold that could cause injury or illness including but not limited to heat exhaustion or stroke, sunburn, frost bite, hypothermia, and dehydration; staying overnight remote or survivalist camping; contact with animals, plants, insects and biological or environmental hazards; use of facilities, roads, sidewalks, parking lots, and trails that may or may not be properly maintained; activities supplemental to the Activity, such as walking or hiking to and from sites of interest; exposure to contaminated food and untreated water; risk related to the rendering or receipt of emergency first aid, or other emergency treatment, and transport in medical emergencies; accident or illness in locations without access to appropriate medical facilities or supplies; and other unknown and unanticipated activities and risks.

I hereby consent to first aid, emergency medical care and if necessary, admission to a hospital when necessary for administering such care, for treatment for injuries or illness that I may sustain while participating in the Activity.
