The meeting was called to order by Chair, Jan Kent, at 7:00 PM.

#### MINUTES:

- Minutes were read by those present. Corrections:
- The next meeting should have read February 9, 1998, not February 5, 1998.
- The County Commissioners delayed the decision on the termination of the sale agreement to February 16, 1998, not February 10, 1998, as stated in the minutes *Pat Eberhardt* moved to approve the minutes as corrected. *Scott Meyer* seconded. Motion passed.

Wayne Krasselt asked about coverage by Extension of FFA animals. Bob Carver stated that Extension did cover the FFA. Steve Braun said he had asked Doug Whitney and had been told that Extension did not cover FFA under the present terms of the contract.

Jan Kent talked about the letter sent to the Fair Board asking for clarification on sale proposal. She also presented a copy of a draft from the fair board.

*Pat Eberhardt* asked *Bob Carver* to give the position of Extension on this matter. *Bob Carver* stated that Extension had at this time made no decision. He stated some concerns

- The guidelines give too much latitude. He would like to see more defined procedures.
- He felt that extension should appoint extension representatives. He felt the Fair Board should not appoint them.
- Extension will not allow 4-H name or emblem to be used in connection with an open sale.
- Open sale by definition would allow anyone with or without educational project to show and sell. 4-H requires the completion of an educational project over a specified period of time.
- With this would it be possible for a youth, or anyone to purchase an animal from another sale in the area and show and sell it along with those who had worked through the 4-H project area?

Wayne Krasselt asked if the County would be able to regulate who sold and who did not sell. The Fair Board is an arm of the County. His question was, could any county resident be excluded? He also expressed that he had been aware of a movement to turn the county show and sale into an open show for several years.

Scott Meyer asked how many other counties have open sales.

Bob Carver replied none.

**Anita Fales** had contacted other counties and asked them about their sales. Her findings were that others did not have open sales.

Steve Braun indicated they had tried to keep the wording similar so that 4-H could participate.

Wayne Krasselt indicated that since FFA has 15% of the animals in the sale he felt they had more than ample representation on the Sale Committee.

Annette Olson said she had researched and back in 1988, 89 and 90 the sale committee was not under the present guidelines. The present agreement was signed in 1991. (That is the agreement that has now been canceled by the Commissioners). She felt from her findings that prior to 1988 the Jaycees had control of the sale. She stated that as of February 16, 1998, the County Commissioners had canceled the contract with 4-H and now the Fair Board has the authority.

Scott Meyer said he felt it was a control issue. He is not sure extension need control of the sale.

Jan Kent said the clerking of the sale was by the Jaycees, and *Percilla Johnson* wrote checks, Jan Kent ran the sale at the time the fair board was supposedly in charge of the sale.

*Bob Carver* said that in 1989 *Steve Maki* had made a motion for the fair board to do the sale. Nothing was done about this.

Wayne Krasselt said that Lewiston Livestock was hired by extension to handle the sale.

FFA indicated they felt they had not been represented at meetings.

Wayne Krasselt said the fair board does not feel compelled to enter into an MOU with extension.

Wayne Krasselt moved the existing contract (sale agreement) be recommended for acceptance with the Fair Board being sub contracting party instead of the commissioners. The 4-H and FFA guidelines presently put forward in 1997 be used. The recently passed sale committee to be acceptable as the committee under the sale agreement. *Don Scoles* seconded.

Discussion followed: The contracting parties were U of I (Extension) and Commissioners.

Five yes, 3 no and 8 abstaining. Motion carried.

*Debbie Evans* asked if Extension will pull from the fair if an agreement is not reached.

*Bob Carver* stated that extension follows through with 99% of the things leaders request. These must meet Federal Requirements for extension to accept them.

After much discussion *Don Scoles requested* to recall the motion for reconsideration. *Gayle Marek* seconded. *13 yes, three abstaining.* Motion recalled.

Reconsideration of the motion: Two yes, six no, 3 abstaining. On reconsideration the motion failed.

Annette Olson made a motion to go back to the Fair Board and tell them that 4-H approved the draft presented, and wishes to participate at the fair. Requesting some concession, specifically:

- Floor checks the next day, or as soon as the funds are available.
- Goats be added to the sale list.
- Each group will select their representatives and be confirmed by the fair board.

After some discussion Annette Olson rescinded her motion.

*Cindy Newton* moved to set up a committee to review points of the draft and make corrections it would like to see to the fair contract. This could include Bob, Jan

Kent, with three others. This committee should have the letter to the fair board by February 23, 1998. *Ann Thompson* seconded. *12 yes* the motion passed.

Wayne Krasselt moved to leave the make-up of the committee to the chair. Debbie Evans seconded. Eight yes, one no, four abstaining the motion carried.

Scott Meyer suggested Wayne Krasselt, and Cindy Newton be members of the committee.

Jan Kent asked Pat Eberhardt if she would attend the Fair Board Meeting in her stead, as she would be unable to attend. Pat agreed.

The meeting was called to order at 7:00 P.M. by Chair, Jan Kent.

Anita Falen gave a report on the meeting of the Fair Board. She stated that the document that the Livestock Leaders had felt was only a draft was according to the meeting a final. She was told it had been voted in at the February meeting as was final. She said they were not on the agenda and were not allowed to speak at this meeting.

Annette Olson stated that there was a resolution at the Fair Board meeting to accept the draft. She felt that the sub-committee had not done as directed. They were not specific enough in their requests.

Jan Kent replied that there were just too many changes to put them down. Therefor they had come up with the two options to be presented to the Fair Board.

Jan Kent read the letters she had received from the Fair Board.

The first letter stated that the Fair Board had adopted the guidelines February 2, 1998. The Fair Board will appoint the members of the Sale Committee on April 10, 1998. They have requested that the nominations be in by March 24, 1998, for these positions.

The second letter received February 23, 1998, stated that a vote had been taken on February 2, 1998, and was unanimous. This document was not a draft, but the final.

- Section 4-A clearly states must be 4-H or FFA youth. They must meet guidelines. 4-H and FFA will be responsible for reporting in writing if a youth is not eligible to sell.
- The sale committee will not use the 4-H symbol or name unless specific permission is granted from extension.

Jan Kent read the resolution form the Fair Board. It stated that the contract with extension and the county commissioners had been terminated as of February 16, 1998. All fair board members except Tom Trail signed this.

Annette Olson said she felt that the Fair Board had specifically responded to all the questions that they were able to glean from the letter from the committee.

Wayne Krasselt read "Latah County 4-H Leaders Council, Latah County 4-H Livestock Leaders resolution 01-98" and "02-98"

Annette Olson questioned why did it not address specific concerns. It looked like the only issue was that the contract be with the University.

**Bob Carver** said in a letter dated March 2, 1998, the legal council for Extension had stated that it would be inappropriate to have outside approval of the extension representatives on the sale committee.

- 4-H must have control if the 4-H emblem or name is used.
- The state law reads that the Fair Board is responsible for the facilities.
- Nothing in the state law authorizes the Fair Board to take responsibility for 4-H projects.
- If 4-H is used in conjunction with a project it must be under the control of extension.
- The resolution says there is a desire to cooperate with the Fair Board, there is a desire to have the sale at the fair. This is what county and state recognize.

Annette Olson said that the Fair Board proposal does not state that the fair board will have final say in what animals sell.

There were concerns expressed about where things will end up. 4-H had had two rooms for exhibits in the past. It was reported that one room was used for a train exhibit. It was said that when a complaint had been registered they were told they could take 4-H to the mall if they didn't like what they were given.

There was also a concern that the fair board would override extension if there was an animal not eligible for sale.

**Buck Wright** said that the proposal gave representation from all aspects of the program.

**Bob Carver** said the letter responding to the committee letter did state that 4-H could nominate their representatives. The original document (Latah County Livestock Sale guidelines) however did not so state.

Jan Kent asked FFA of their intentions if 4-H removed itself from the fair.

**Buck Wright** asked for a clarification of **Jan's** statement. He stated that the commissioners had already made a decision.

Jan Kent said she felt that 4-H had not had any input into to commissioner's decision.

Annette Olson said that Wayne Krasselt and Bob Carver were at the meeting.

Jan Kent asked Twila Brown why the Fair Board had taken it upon themselves to take over something that was working well.

**Twila Brown** responded that the Fair Board was covering all their bases. The Fair Board had not seen proof of insurance. She said the Fair Board does not want to run the sale. They have enough to do without it. They are only wanting to make sure they are covered.

Annette Olson said the Sale Committee had handled the sale without extension help. Due to the change in personnel in the office the Sale Committee had been asked to do as much as they could since the office was short handed. She said the sale committee had planned and worked their own computer program. She said they did it all. She stated that the sale ran smoothly. She stated that the Fair Board was asked by the Livestock Sale Committee to request the cancellation of the contract.

**Bob Carver** asked for a time when this had passed. He stated he had attended every meeting since April. He said he had not been able to find anything in the minutes relating to passing a motion to request the change. He said according to the minutes he had been able to find there was no motion made.

The response was that it happened around April while the problems with the Chip Gillham fund were being worked on.

**Pat Eberhardt** said she was at the recent Fair Board meeting. It was her understanding that the Commissioners would no longer be a contracting party. She feels that there should be a contract between the Fair Board and Extension.

Twila Brown said Doug Whitney stated that it is a mater of formality. If 4-H had five people it should be acceptable.

**Pat Eberhardt** indicated she felt that there should be a contract with 4-H and FFA the same as the Fair Board would have with Davis Shows. This would allow the control of the sale to be with Extension. Could we re-instate the current committee and get started so that the program can continue?

Wayne Krasselt stated he had attended meetings and had reviewed minutes. He has been unable to find a vote to restructure the Livestock Sale Committee. For it to have been official he feels it should have come before the Livestock Leaders Committee for approval before going any further.

Jan Kent asked Nancy Richmond if she had brought this proposal before the Livestock Leaders Committee.

**Nancy Richmond** stated that to the best of her recollection it had been discussed at the Livestock Leaders Meeting.

Wayne Krasselt stated that he was at the meeting when the County Commissioners reacted to the request. They said they have a policy of long-term contracts, but have not had a policy with short-term contracts. His research indicates that Counties should not be so bound. He feels it is clear that the Fair Board wants control of the Sale Committee, but not to run the sale. Jan Kent asked Bob Carver if Legal from the University had gotten together with Doug Whitney to try to resolve this problem

Don Scoles said he wants to work together for the best interests of the youth.

Twila Brown said she would call the Fair Board to put this question on the agenda.

**Pat Eberhardt** stated that two options were put forward to help. 4-H feels they can not dictate to FFA. The two options were so FFA could stay with 4-H in this matter, or separate themselves if they felt that 4-H was not doing what they felt FFA could do.

Gayle Marek wondered if there is a window of opportunity for change, or must we just move on.

Twila Brown said 4-H needs to make nominations soon or there will not be time enough to get them on the committee.

Jan Kent asked Bob Carver to set up a meeting with extension legal.

Leslie Sprouse said to her the original resolution by the Fair Board sounds like they will take over. She wondered if under direct control of the Fair Board, Latah County Fair, for the young people of Latah County, is it possible for the Fair Board to discriminate against any youth?

Anita Falen said her understanding from what she had been told by University Legal is that the Fair can not take over the sale.

**Pat Eberhardt** made a motion to pass resolution 01-98 with the correction in the second paragraph. The paragraph should read WHEREAS, the Latah County Fair Board has even determined to be the proper party to <u>contact</u> <u>contract</u> for use of the county property designated for fair purposes. **Anita Falen** seconded.

After some discussion **Pat Eberhardt** amended that changes may be made by Extension Legal to allow 4-H to agree. This needs to be done by April 6, 1998. **Anita Falen** seconded.

A secret ballot was called for. 19 yes and three no. Motion carried.

**Pat Eberhardt** made a motion to pass resolution 02-98 allowing changes to be made by Extension Legal to allow 4-H to agree. This needs to be done by April 4, 1998. **Debbie Evans** seconded.

A secret ballot was called for. 19 yes and four no.

Wayne Krasselt moved to accept the count. Jan Jacobs seconded. Motion carried.

Leslie Sprouse moved to request the facility for the sale at fair time. Debbie Evans seconded. Motion carried.

Jan Kent said she will write a cover letter and take care of the request.

After some talk about the tags needed for weigh-in **Gayle Marek** made a motion to have the tags paid for by the youth at weigh-in. **Nancy Richmond** seconded. Motion carried.

**Scott Meyer** moved to use USDA tags again this year. The motion was seconded. The motion passed.

The scale should be requested for use at weigh-in. There was also talk of the scale needing to be available at other times for youth in the livestock projects.

Meeting called to order at 6:59 p.m.

Fair: Will have a list of Community Service for the clubs to do at the Fairgrounds. This will be a way for the clubs to give back to the Fairgrounds. The cleaning of the barns will be approximately 2 weeks after the fair.

Species Report: Pig weigh-in Friday, June 8, 2007. Scales will be moved. Tim Yockey and Jim Frederickson will set up on Thursday for Friday weigh-in. Barb Jaworski and Nick Egland will need help with vaccinations.

Sheep weigh-in on July 11, 2007. Martin will not be shearing at initial weigh-in. Weigh-in will be from 5:00 p.m. to 7:00 p.m. There will be approximately 50 animals at weigh-in.

Abby and Jan will decide within the next week if we should do a clinic at the initial weigh-in or if we will wait until the August 8, 2007 weigh-in.

Need to remind members to keep their animals protected from wild animals such as wolves. There has already been one pig killed.

EID tags need to be in all species.

Goats: No horns will be in effect with goats. Goats will weigh-in at sheep weigh-in. There are 5 goat projects this year.

Clinics: Bridle kids liked the clinic. Mauri will ask them to do it again next year.

Motorcycle Classic: There will be a Motorcycle Classic meeting at the Fairgrounds on June 6 at 3:45 p.m. Sign-up sheet will be in the mail. Every Club must work at the Motorcycle Classic. All kids that participate in helping with the Classic will get to go to Hamilton Pool. Every member must do livestock judging. They can participate in other livestock judging's before the Latah County Fair. If members do not judge before the fair they have to judge on Sunday of the judging contest at the fair.

We discussed how to control keeping members at the fair until 5:00 p.m. on Sunday. The members will be required to care for their animal while it is at the fair from Wednesday through Sunday. Also discussed that is does not matter when the animal sells, members still must stay until the end of the fair, this is also stated in the Policies and Procedures. If there is any negligence going on at the fair, please alert a leader or Mauri.

Other: 4-H camp applications have gone out and are due by June 15, 2007. Teen leaders are needed. Potlatch Summer Camp will be June 18-22, 2007, teen leaders will be needed, call Mauri or Andrea. There will be a Livestock judging camp in Gooding, Idaho on July 16-19, 2007. Need to get curriculum ordered now and get it done.

Mauri will be out of the office 1<sup>st</sup> week in August and 20<sup>th</sup> of August.

Mauri Knott announced her resignation of the county 4-H program coordinator position; April 5, 2010 will be her last day. #### **Committee Reports:**

1. Policy Committee – Proposal (attached).

Discussion: Remove the word "our" from the second sentence, remove "we" at the beginning of the third sentence and begin with "The 4-H members", remove the word "our" from that sentence. Discussion included why weight changes are being proposed: to reflect current markets and expectations of youth as producers. Minimum and maximum weights are set by the Latah Market Animal Sale committee and therefore any changes approved by the livestock leaders tonight will be shared with the Leaders Council. If they are approved by Leader's Council they will then be given as recommendations to the LMAS board for final approval. There are no "maximum" weights per se in Latah County. Youth who enter animals over this weight are still eligible to compete at all levels at fair. In the past some sheep judges have been told they could not let these youth compete in grand champion rounds. Discussion included that superintendents should know Latah County 4-H does not discriminate against animals that are over maximum weight and communicate this to judges. This weight is only to "protect buyers" by giving them a maximum weight they have to pay for. There was confusion about this document. It was pointed out that this is only one page of the Latah County 4-H Livestock Policy. The entire policy was not provided by the committee members at this meeting. Consensus was to discuss only weights tonight and no other text in this document. Next discussion was regarding why these weights have been chosen. Goats were not in current Latah County 4-H Livestock Policy. These weights are proposed from research with other states that have market goat projects. Poultry was proposed to follow USDA guidelines for each breed due to the variation between birds including quail to turkeys. Rabbits have a national standard that they must follow. Swine was stated in the current policies as 255 to 255. Sheep changes are proposed based on feedback from some local producers that Nancy and Arvilla spoke with. Kim Monk shared that she spoke with local producers as well and her feedback does not support the proposed change. It was agreed by all present to review each species for approval/disapproval. There are no proposed changes to beef therefore no motion needed.

Debbie Lawrence moved to recommend 70 to 120 lbs for goats, seconded by Beth Cree unanimous approval, motion passed.

Beth Cree moved to recommend "See USDA Poultry" for poultry, seconded by Debbie Lawrence unanimous approval, motion passed.

Debbie Lawrence moved to recommend 3 to 5 lbs for rabbits, seconded by Beth Cree unanimous approval, motion passed.

## INDUSTRY STANDARD GUIDELINES FOR MARKET PROJECTS:

The Latah County 4-H & FFA Market Animal Sale, Inc. has established new weight requirements for 4-H Market Animal Projects: Beef, Swine, and Sheep. The weight requirements are designed to keep our market animals in line with the "industry standards". We must constantly strive to produce the quality and size of animal that our buyers (including packing houses) want. These weights apply to the "at-Fair/Final weigh-in" in September.

\*Beef over 1, 500 lb., swine over 280 lb., sheep over 160 lb., will sell at the maximum allowed weight (1500 lb beef, 280 lb. swine, 150 lb. sheep) Animals that go over their species maximum weight will sell at the maximum weight listed above.

\* Rabbits are not allowed to sell if they do not meet the above parameters.

\* Species with non-traditional breeds minimum and maximum weights will be determined as needed.

Kelli,

I will not be able to make Livestock Leaders tonight as I have family obligations. I reviewed the policy changes and understand that the committee has been working on this for a couple months which is much appreciated. In the first paragraph the words "our" and "we" should be changed to "the 4-H and FFA member", as it is their project not the programs project. Give them direct ownership and responsibility.

I also have questions and concern regarding the last bullet point: "Species with non-traditional breeds minimum and maximum weights will be determined as needed" What species is this referring too? What is considered a non-traditional breed? Who will determine the weights? Are we allowing exotics now as meat animals?

This bullet seems very ambiguous and open for too much interpretation. This could be a huge loop hole that could cause a lot of headache down the road.

For example: Johnny Sue could bring a Brahma Angus cross steer to the fair that only weights 1025 lbs. After weigh-in her irate dad could bring you this policy and say that she must be able to sell because her steer is 1/2 Brahma, which he considers to be a "non-traditional" meat breed and after all Brahma's are small framed animals so this steer is finished and should sell.

This bullet could lead to fair time conflicts for members, parents, leaders, LMAS and the Extension Office. I would strongly encourage Livestock Leaders to remove this bullet from their recommendations. Please feel free to share my email tonight at the meeting.

Please share my comments. Just for clarification purposes on a national standard any low-line cattle breeds compete separately from beef cattle, therefore they would need a class/division of their own that would need to be put together as a whole separate project not as a different policy to an existing project. Also, note that any new species would need to be approved by LMAS to go through their sale first; just because a child enrolls in a market project in a species does not guarantee that LMAS will offer that species for sale through there sale. I think Livestock Leaders would need to put a policy in place if the need arose and circumvent the chance for conflict with this open ended policy.

Jackson Davis was mentioned, so LMAS is taking any recommendations for a new person. Tags were ordered, fees the same, community doing barns, runners, tent will be assigned. The Fair dates are September 16-20, with September 16<sup>th</sup> the final weigh-in for market projects.

Tammie Johnston thought a meeting to orientate youth and parents was needed at the fair. Kelli stated she wanted an orientation meeting, but was not sure there was enough time.

Swine tag assignment is due to Kelli by June 24<sup>th</sup> and possession date is June 8<sup>th</sup>, 2015. Last year there were 121 swine projects, this year 144.

Beef weigh-in will be held April 25<sup>th</sup> from 7-9 a.m. at the Monson Barn. Barb will help?

Sheep weigh-in is July 9<sup>th</sup> from 5-7 p.m. at the Latah Fairgrounds. Kelli has contacted Martin Dibble to shear that day.

Avian Influenza (Bird Flu) – Kelli had talked to Scott Barnes, north Idaho State Vet, about bird flu. He stated if 1 bird dies okay, but if more than 1, then call the vet. The test procedure takes blood out of the wing of the bird. Not a fun process to do or watch. Water fowl are the main problem. Be careful buying birds from hatcheries and buying privately. Washing hands often helps. Ask people in barns to wash hands. The fair book says poultry must be tested, but most are not tested. Last year fair pigs did NOT go home, so something similar may be done with poultry. Open class poultry people will be the people that will bring birds to the fair and they will go home or for sale at the fair.

Show order for large animals – really it is an age division order. There was some discussion for putting the order the same for all species as the fair book states. It was suggested to keep junior, intermediate and senior for beef and all the other species senior, intermediate, and junior. Possibly the call of the species superintendents.

## New Business

Paula Okerberg has tried to put together a different fair goat class for the goat project youth this year especially youth with new goat projects. There will be market goat, breeding goat, pet goats and pygmy goat classes at the fair. There may be possibly some fiber goats again. Kelli talked to Annette and she did not have a problem with changing the goat class organization. It is not fair to show a freshened goat (goat with an udder) against a dry or doeling goat (no udder). It was moved by Tammie Johnston and 2<sup>nd</sup> by Nancy Richmond to add a section for breeding goat at the fair so there will be class for dry and a freshen breeding goat. Discussion on showing only 1 animal and this class would include all dairy and Nigerian, but no pygmy goats. There was no need to have a wether class as they were already covered in the pet goat class so no need to add them.

Clarification was stated by Anita Falen concerning the sheep/goat areas and getting to the show ring and lamb stand area with sheep/goats. Anita had talked to Annette to clarify. No sheep in the beef area, so sheep must go around the front of the barns to the show ring and lamb stand area. Absolutely no sheep or goats are allowed at the poultry/rabbit barn, concessions area, 4-H building, Grange building, and carnival area or on pavement away from the barns. The area around the livestock show barn will need cleaned-up after show times to make it more pleasing to fair goers and sale buyers. Each goat or sheep barn should make some allowances for youth to clean up on the barn duty list.

Kelli does not want any more travelling plaques for fair projects. Consider a wall plaque that is displayed at the fairgrounds with Annette's approval, and encourage donors to donate plaque and engraving for the life of the plaque.

They weighed in all the steers on April 25<sup>th</sup> but now the child that is taking a swine project wants to take a beef project. May still continue with the swine project but wants to take the floater as a beef project. Kelli stated that every year members want to switch swine projects and/or are not enrolled in the swine project. Some swine youth are not enrolled and the swine are asked to be weighed or changed. Discussion took place by club members and voting delegates. A motion was made by Kim Monk that youth cannot change to a beef project even though the floater was weighed at the official weigh-in. Motion 2<sup>nd</sup> by Edie Simmons. Vote against - Ponderosa, Mt. View, and GLC; vote favor - Country Kids, FMBE, Cow Creek Kids and Troy. Motion passes: 4 in favor, 3 against motion.

Kelli wants a motion that will cover the swine weigh-in as usually the same thing happens after the weigh-in or they are not enrolled in the project. Do the youth have to be enrolled at the time of the weigh-in; therefore, making them not eligible to take the project? Discussion took place on when to not allow youth to take the project. Kelli asked if they weigh in a pig but are not enrolled, can they take the project? Kim Monk moved that the policy for taking a project is that all youth must be enrolled and signed up with extension by the date of possession and weigh-in date or they cannot take the project. Well, it will matter as it has to meet certain requirements for a market goat by the judge. Some problems with the Nigerian Goat in the breeding class. Met requirements by the way they set it up, but the girl showed the baby not the mother for showmanship. Technically it was in the small animal round robin (the baby), so the mother should have been shown not the baby in the breeding class.
