Housing: Teachers will be housed with other adults in a group cabin. Cabins are rustic and not heated. Though electricity and hook-ups are not available, many adults choose to bring personal tents or campers in lieu of staying in the group cabin.

Family: Please DO NOT bring spouses or children unless they are also registered for camp. Youth aged 12-16 years, by the first day of camp, must register separately on the "Natural Resource Camp Student Application" form. All children of teachers must participate fully in the program and must sleep in the cabins designated for youth, not with their parents. Parents and children are expected to have independent experiences at camp.

Instructor: Professor Randy Brooks, University of Idaho Extension.

Purpose: The course is designed to strengthen teachers and youth leaders for formal and informal instruction in natural resource subjects.

Objectives:

1. Understand and apply introductory concepts and practices of natural resource management.
2. Understand and appreciate the importance of natural resources to the economy.
3. Explore and understand the relationship of natural resources to everyday life.
4. Understand how individuals and professional resource managers can employ strategies to conserve natural resources for future generations.
5. Employ techniques which will involve individuals of all ages in the active exploration of natural resources.
6. Explore and develop strategies and techniques which will integrate natural resource education and instruction into academic and vocational educational settings, including the subjects of science, math, history and agriculture.

Content: Hands-on involvement and active exploration will be emphasized along with facts and concepts. Many teachers are finding that natural resource subjects are high-interest ways to teach mathematics, social studies, reading and verbal skills, motor development, science and other traditional curricula. The integration of natural resource subjects can make learning fun. The content will focus on water, soil, wildlife, forestry and range management.

Format: Youth and teachers participate in Natural Resource Camp as equals – a unique situation for both groups and one that has shown positive benefits. The camp is devoted to the education and personal development of both youth and adults. Participants in the camp will learn about themselves as they develop confidence, leadership and social skills.

Requirements: To receive one credit, you must participate in all scheduled activities for the entire camp, pass an examination (or other requirements) set by the instructor and complete a general course evaluation.

To receive one additional credit, each participant must complete a lesson plan for their grade level in one of the major resource subjects taught at the camp. The organization and content of the lesson plan is flexible but should be appropriate for the grade level of the students to be taught. When submitting your assignment, please identify the grade level and subject taught and provide a brief overview of how the content of the lesson plan will be integrated into the subject being taught.

The lesson plan should include the following elements:

1. Purpose and objectives of the lesson.
2. Basic concepts to be learned.
3. Outline of information to be introduced.
4. Teaching techniques to be used.
5. Description of learning activities.
6. Glossary of terms.
7. Resource materials.
8. Evaluation methods for students and course.

Camp Information, Rules and Conduct

NOTICE: Please read this page while filling out the application, read it again while getting ready for Natural Resource Camp and bring this page to camp.

Complete all signatures.

Dates and Location: The 2024 Natural Resource Camp is June 17-22, 2024 at the Central Idaho 4-H Camp, approximately 17 miles north of Ketchum on Highway 75. Turn left at the camp entrance, which is near mile marker #146 – look for the "4-H Camp" sign and mailbox on the side of the road. Take the gravel road 1.2 miles to the camp parking lot.

Transportation: Transportation to and from camp is the responsibility of the camper. The first camp program begins at 1:30 p.m. MDT. Please check with the Idaho Department of Transportation at <http://511.idaho.gov/> for any reported road delays.

Arrival: Campers should arrive at the parking lot between 12:30 and 1 p.m. MDT on Monday, June 17, 2024. Natural Resource Camp staff and cabin leaders will be in the camp's parking lot to greet you, assign campers to cabins and direct registration procedures. Please DO NOT arrive prior to 12:30 p.m., as Natural Resource Camp staff is preparing for registration.

Departure/Pick-Up: Families are encouraged to attend the awards ceremony, which starts at 10 a.m. MDT on Saturday, June 22, 2024.

Cabin assignments: You will be staying in a cabin with other teachers, with male and female teachers in separate cabins. Though electricity and hook-ups are NOT available, teachers are encouraged to bring their own tent or camper. Please be in touch with Randy Brooks prior to camp to discuss accommodations.

Phone: There is NO CELL SERVICE at camp. The Central Idaho 4-H Camp has a private landline for use by camp staff only. This phone may be used by others ONLY in the case of an emergency and you will need a calling card to pay for your long distance call. In the case of an emergency, you may call the camp landline at 208-726-4519. Ask for Randy Brooks, Natural Resource Camp director. Messages can be left on the answering machine.

What to Bring: The Central Idaho 4-H Camp is at 7,000 feet elevation. The cabins are not heated and nights may go below freezing. Afternoon activities can be in hot or cold conditions.

Bring:

- Warm sleeping bag and a pillow
- Knit hat, gloves, scarf and several pairs of warm socks
- Several changes of clothing for hot and cold temperatures – layering works well
- Personal articles
- Shower shoes
- Two pairs of sturdy shoes (broken-in for blister prevention)
- Flashlight

- Swimsuit and towel for swimming at Easley's Hot Springs
- Insect repellent and sunscreen
- Canteen or water bottle
- Daypack

A blanket, alarm clock, fishing pole and Idaho fishing license, camera, charged batteries, film/memory cards, acoustical musical instruments and journal or address book may also be brought to camp.

DO NOT bring:

- Cell phones
- Electronics, stereos, iPods and/or radios
- Firearms
- Fireworks
- Knives
- Alcohol
- Illegal substances
- Non-prescription medications

Camp Rules of Conduct and Responsibilities: Following these rules will ensure that everyone will have a safe and enjoyable camp experience.

1. Natural Resource Camp directors reserve the right to search items brought to camp by any individual (youth, teachers, cabin leaders and staff).
2. Items from the "DO NOT bring" list that are brought to camp, or any other item deemed unnecessary by Natural Resource Camp staff, will be confiscated and, if appropriate, returned to the participant upon departure.
3. Campers and cabin leaders will stay within the camp boundaries, except for scheduled off-site camp activities.
4. DO NOT build fires in any area, at any time.
5. Campers are responsible for keeping their cabin clean.
6. Campers are responsible for lost or stolen items.
7. Campers and cabin leaders need to be in their cabins at 10 p.m., with lights out and quiet by 10:30 p.m. MDT.
8. Campers will participate in all scheduled activities and are expected to be on time.
9. All campers are to stay with their class or activity until dismissed. Rudeness, disrespect and interruptions will not be tolerated.
10. Make showers short and use a minimum of hot water. Please clean up after yourself in the shower house. Campers misusing shower facilities will be responsible for cleanup.
11. Stay in defined walkways on camp premises. Treat wildlife, plants and facilities with respect. No carving on trees, throwing rocks, harassing wildlife or defacing the facilities. If you BREAK IT OR DEFACE IT, YOU pay for it or REPLACE IT.
12. Crosscut saws and other tools may be used only with permission and adult supervision during the "Tournament of the Outdoors."
